## DISCOVER 2026 – Thursday 16<sup>th</sup> July 2026, Total Wipeout – £18.00

As part of the Discover 2026 programme for KS3 students, your child has been selected to attend the trip to Total Wipeout, Bluewater on Thursday 16<sup>th</sup> July 2026.

Students are not required to wear school uniform for the trip, but should ensure they are dressed appropriately (i.e. no shorts above mid-thigh/ripped jeans or crop tops, and no false nails or lashes). If students decide to bring electrical items with them, the school will not take any responsibility if anything is lost or damaged during the trip.

### Activities on the day

Students will spend the afternoon on the water, bouncing, swimming, scrambling and sliding their way around this floating, inflatable assault course. Wet suits and buoyancy aids will be provided. Due to the timings of the day, students may have to eat their packed lunch on the minibus. Please ensure that an appropriate packed lunch is provided.

### Transport

Students will make the return journey to Bluewater on the school minibus.

### Timings of the trip

Students should meet their trip leaders in **room 34 at 11.45am** to journey to Bluewater. They will return to school for approximately 3.00pm

### Cost of the trip

The cost of the visit will be £18.00, that includes entry to the course, safety instruction and equipment. The deadline for payment is **Friday 1<sup>st</sup> May 2026**. We are a cashless school, so payments must therefore be made via Wisepay (our on-line payment portal). You can access our school payment system by:

All monies paid for the Discover Activities are non-refundable. This is because we must pay for the venues, providers, equipment etc. in advance. Your child's participation in any activities is at the school's discretion and decisions to revoke places on activities may be made on the basis of poor behaviour and with consideration of safeguarding risk-both to your child and to other participants and staff.

What students are required to bring for the day:

- A packed lunch (possibly to be eaten on the minibus)
- Swimwear
- A towel
- Sun block
- **A bottle of water**

### Medication

Having read and understood all the information about this trip, and by paying the sum of £18.00 via Wisepay, you have agreed for your child to take part in all activities outlined. The school will continue to use all medical and contact information that you provided upon admission for this activity/trip if and where required.

**A safety waiver is required for this activity. A form will be sent to you for completion nearer the time. Failure to complete this waiver will result in your child not being able to participate. All participants must be competent swimmers.**
