I. Aims

Our school aims to:

- > Have robust processes in place to ensure the online safety of students, staff, volunteers and governors
- > Identify and support groups of students that are potentially at greater risk of harm online than others
- Deliver an effective approach to online safety, which empowers us to protect and educate the whole school community in its use of technology, including mobile and smart technology (which we refer to as 'mobile phones')
- > Establish clear mechanisms to identify, intervene and escalate an incident, where appropriate

The 4 key categories of risk

Our approach to online safety is based on addressing the following categories of risk:

- Content being exposed to illegal, inappropriate or harmful content, such as pornography, fake news, racism, misogyny, self-harm, suicide, antisemitism, radicalisation and extremism
- Contact being subjected to harmful online interaction with other users, such as peer-to-peer pressure, commercial advertising and adults posing as children or young adults with the intention to groom or exploit them for sexual, criminal, financial or other purposes
- Conduct personal online behaviour that increases the likelihood of, or causes, harm, such as making, sending and receiving explicit images (e.g., consensual and non-consensual sharing of nudes and semi-nudes and/or pornography), sharing other explicit images and online bullying; and
- > Commerce risks such as online gambling, inappropriate advertising, phishing and/or financial scam

2. Legislation and guidance

This policy is based on the Department for Education's (DfE's) statutory safeguarding guidance, <u>Keeping Children Safe</u> in Education, and its advice for schools on:

- > <u>Teaching online safety in schools</u>
- > Preventing and tackling bullying and cyber-bullying: advice for headteachers and school staff
- > [Relationships and sex education
- > Searching, screening and confiscation

It also refers to the DfE's guidance on protecting children from radicalisation.

It reflects existing legislation, including but not limited to the <u>Education Act 1996</u> (as amended), the <u>Education and</u> <u>Inspections Act 2006</u> and the <u>Equality Act 2010</u>. In addition, it reflects the <u>Education Act 2011</u>, which has given teachers stronger powers to tackle cyber-bullying by, if necessary, searching for and deleting inappropriate images or files on students' electronic devices where they believe there is a 'good reason' to do so.

The policy also takes into account the National Curriculum computing programmes of study.

3. Roles and responsibilities

3.1 The governing body

The governing body has overall responsibility for monitoring this policy and holding the headteacher to account for its implementation.

The governing body will make sure all staff undergo online safety training as part of child protection and safeguarding training, and ensure staff understand their expectations, roles and responsibilities around filtering and monitoring.

The governing body will co-ordinate regular meetings with appropriate staff to discuss online safety, requirements for training, and monitor online safety logs as provided by the designated safeguarding lead (DSL).

The governing body should ensure children are taught how to keep themselves and others safe, including keeping safe online.

The governing body must ensure the school has appropriate filtering and monitoring systems in place on school devices and school networks, and will regularly review their effectiveness. The body will review the DfE filtering and monitoring

standards, and discuss with IT staff and service providers what needs to be done to support the school in meeting thesee standards, which include:

- Identifying and assigning roles and responsibilities to manage filtering and monitoring systems;
- Reviewing filtering and monitoring provisions at least annually;
- Blocking harmful and inappropriate content without unreasonably impacting teaching and learning;
- Having effective monitoring strategies in place that meet their safeguarding needs.

The governor who oversees online safety is Andy Lane

All governors will:

- > Ensure they have read and understand this policy
- > Agree and adhere to the terms on acceptable use of the school's ICT systems and the internet (appendix 2)
- > Ensure that online safety is a running and interrelated theme while devising and implementing their whole-school or college approach to safeguarding and related policies and/or procedures
- Ensure that, where necessary, teaching about safeguarding, including online safety, is adapted for vulnerable children, victims of abuse and some students with special educational needs and/or disabilities (SEND). This is because of the importance of recognising that a 'one size fits all' approach may not be appropriate for all children in all situations, and a more personalised or contextualised approach may often be more suitable

3.2 The Headteacher

The headteacher is responsible for ensuring that staff understand this policy, and that it is being implemented consistently throughout the school.

3.3 The designated safeguarding lead (DSL) and the Strategic ICT Lead (AHT)

Details of the school's designated safeguarding lead (DSL) are set out in our child protection and safeguarding policy, as well as relevant job descriptions.

The DSL takes lead responsibility for online safety in school, in particular:

- Supporting the headteacher in ensuring that staff understand this policy and that it is being implemented consistently throughout the school
- > Ensuring that any online safety incidents are logged on safeguard my school and dealt with appropriately in line with this policy
- > Managing all online safety issues and incidents in line with the school's child protection policy
- > Undertaking annual risk assessments that consider and reflect the risks children face
- Providing regular safeguarding and child protection updates, including online safety, to all staff, at least annually, in order to continue to provide them with relevant skills and knowledge to safeguard effectively
- > Liaising with other agencies and/or external services if necessary
- Ensuring that any incidents of cyber-bullying are logged and dealt with appropriately in line with the school behaviour policy
- > Updating and delivering staff training on online safety as part of the safeguarding training

3.4 Strategic ICT Lead (AHT):

- > will ensure that all technical issues are resolved
- > Working with the ICT manager to make sure the appropriate systems and processes are in place
- Working with the headteacher, ICT manager and other staff, as necessary, to address any online safety issues or incidents
- Taking the lead on understanding the filtering and monitoring systems and processes in place on school devices and school networks
- > Working with the headteacher and governing board to review this policy annually and ensure the procedures and implementation are updated and reviewed regularly

3.5 The ICT Network Manager

The ICT manager is responsible for:

- Putting in place an appropriate level of security protection procedures, such as filtering and monitoring systems on school devices and school networks, which are reviewed and updated at least annually to assess effectiveness and ensure students are kept safe from potentially harmful and inappropriate content and contact online while at school, including terrorist and extremist material
- Ensuring that the school's ICT systems are secure and protected against viruses and malware, and that such safety mechanisms are updated regularly
- > Conducting a full security check and monitoring the school's ICT systems on a weekly basis
- Blocking access to potentially dangerous sites and, where possible, preventing the downloading of potentially dangerous files
- > Ensuring that any online safety incidents are logged on safeguard my school and dealt with appropriately in line with this policy
- > Ensuring that any incidents of cyber-bullying are dealt with appropriately in line with the school behaviour policy

This list is not intended to be exhaustive.

3.6 All staff and volunteers

All staff, including contractors and agency staff, and volunteers are responsible for:

- > Maintaining an understanding of this policy
- > Implementing this policy consistently
- Agreeing and adhering to the terms on acceptable use of the school's ICT systems and the internet (appendix 3), and ensuring that students follow the school's terms on acceptable use (appendices 1 and 2)
- Knowing that the DSL is responsible for the filtering and monitoring systems and processes, and being aware of how to report any incidents of those systems or processes failing by adding this to safeguard my school.
- Following the correct procedures by informing CTS (who will inform Netsweeper directly) of certain topics that will trigger an alert via the filtering and monitoring systems for educational purposes
- > Working with the DSL to ensure that any online safety incidents are logged on safeguard my school and dealt with appropriately in line with this policy
- > Ensuring that any incidents of cyber-bullying are dealt with appropriately in line with the school behaviour policy
- Responding appropriately to all reports and concerns about sexual violence and/or harassment, both online and offline, and maintaining an attitude of 'it could happen here'

This list is not intended to be exhaustive.

3.7 Parents/carers

Parents/carers are expected to:

- > Notify a member of staff or the headteacher of any concerns or queries regarding this policy
- Ensure their child has read, understood and agreed to the terms on acceptable use of the school's ICT systems and internet (appendices 1 and 2)

Parents/carers can seek further guidance on keeping children safe online from the following organisations and websites:

- > What are the issues? <u>UK Safer Internet Centre</u>
- > Hot topics <u>Childnet</u>
- > Parent resource sheet Childnet

3.8 Visitors and members of the community

Visitors and members of the community who use the school's ICT systems or internet will be made aware of this policy, when relevant, and expected to read and follow it. If appropriate, they will be expected to agree to the terms on acceptable use (appendix 3).

4. Educating students about online safety

Students will be taught about online safety as part of the curriculum:

The text below is taken from the National Curriculum computing programmes of study.

It is also taken from the guidance on relationships education, relationships and sex education (RSE) and health education.

All secondary schools have to teach:

> <u>Relationships and sex education and health education</u> in secondary schools

At Blackfen School for Girls, in KS3, students will be taught to:

- Understand a range of ways to use technology safely, respectfully, responsibly and securely, including protecting their online identity and privacy
- > Recognise inappropriate content, contact and conduct, and know how to report concerns

Students in **KS4** will be taught:

- > To understand how changes in technology affect safety, including new ways to protect their online privacy and identity
- > How to report a range of concerns

By the end of secondary school, students will know:

- Their rights, responsibilities and opportunities online, including that the same expectations of behaviour apply in all contexts, including online
- About online risks, including that any material someone provides to another has the potential to be shared online and the difficulty of removing potentially compromising material placed online
- Not to provide material to others that they would not want shared further and not to share personal material that is sent to them
- > What to do and where to get support to report material or manage issues online
- > The impact of viewing harmful content
- > That specifically sexually explicit material (e.g., pornography) presents a distorted picture of sexual behaviours, can damage the way people see themselves in relation to others, and negatively affect how they behave towards sexual partners
- > That sharing and viewing indecent images of children (including those created by children) is a criminal offence that carries severe penalties including jail
- > How information and data is generated, collected, shared and used online
- How to identify harmful behaviours online (including bullying, abuse or harassment) and how to report, or find support, if they have been affected by those behaviours
- > How people can actively communicate and recognise consent from others, including sexual consent, and how and when consent can be withdrawn (in all contexts, including online)

The safe use of social media and the internet will also be communicated with students in assemblies and parents and carers in home communications.

Where necessary, teaching about safeguarding, including online safety, will be adapted for vulnerable children, victims of abuse and some students with SEND.

5. Educating parents/carers about online safety

The school will raise parents/carers' awareness of internet safety in letters or other communications home, and in information via our website or virtual learning environment (VLE). This policy will also be shared with parents/carers.

Online safety will also be covered during communication home.

The school will let parents/carers know:

- > What systems the school uses to filter and monitor online use
- What their children are being asked to do online, including the sites they will be asked to access and who from the school (if anyone) their child will be interacting with online

If parents/carers have any queries or concerns in relation to online safety, these should be raised in the first instance with the headteacher and/or the DSL.

Concerns or queries about this policy can be raised with any member of staff or the headteacher.

6. Cyber-bullying

6.1 Definition

Cyber-bullying takes place online, such as through social networking sites, messaging apps or gaming sites. Like other forms of bullying, it is the repetitive, intentional harming of 1 person or group by another person or group, where the relationship involves an imbalance of power. (See also the school behaviour policy.)

6.2 Preventing and addressing cyber-bullying

To help prevent cyber-bullying, we will ensure that students understand what it is and what to do if they become aware of it happening to them or others. We will ensure that students know how they can report any incidents and are encouraged to do so, including where they are a witness rather than the victim.

The school will actively discuss cyber-bullying with students, explaining the reasons why it occurs, the forms it may take and what the consequences can be. Student support officers will discuss cyber bullying with their communities and form tutors with their tutor groups.

Teaching staff are also encouraged to find opportunities to use aspects of the curriculum to cover cyber-bullying. This includes personal, social, health and economic (PSHE) education, and other subjects where appropriate. At Blackfen, PSHE is part of the Social, Personal and Cultural Studies Curriculum.

All staff, governors and volunteers (where appropriate) receive training on cyber-bullying, its impact and ways to support students, as part of safeguarding training (see section 11 for more detail).

The school also sends information on cyber-bullying to parents/carers so they are aware of the signs, how to report it and how they can support children who may be affected.

In relation to a specific incident of cyber-bullying, the school will follow the processes set out in the school behaviour policy. Where illegal, inappropriate or harmful material has been spread among students, the school will use all reasonable endeavours to ensure the incident is contained.

The DSL will report the incident and provide the relevant material to the police as soon as is reasonably practicable, if they have reasonable grounds to suspect that possessing that material is illegal. They will also work with external services if it is deemed necessary to do so.

6.3 Examining electronic devices

The headteacher, and any member of staff authorised to do so by the headteacher our behaviour policy and the searching, screening and confiscation policy_can carry out a search and confiscate any electronic device that they have reasonable grounds for suspecting:

- > Poses a risk to staff or students, and/or
- > Is identified in the school rules as a banned item for which a search can be carried out, and/or
- > Is evidence in relation to an offence

Before a search, if the authorised staff member is satisfied that they have reasonable grounds for suspecting any of the above, they will also:

- Make an assessment of how urgent the search is, and consider the risk to other students and staff. If the search is not urgent, they will seek advice from Student Welfare Manager or the DSL
- Explain to the student why they are being searched, how the search will happen, and give them the opportunity to ask questions about it
- > Seek the student's co-operation

Authorised staff members may examine, and in exceptional circumstances erase, any data or files on an electronic device that they have confiscated where they believe there is a 'good reason' to do so.

When deciding whether there is a 'good reason' to examine data or files on an electronic device, the staff member should reasonably suspect that the device has, or could be used to:

- Cause harm, and/or
- > Undermine the safe environment of the school or disrupt teaching, and/or
- > Commit an offence

If inappropriate material is found on the device, it is up to the staff member, in conjunction with the Student Welfare Manager or DSL, to decide on a suitable response. If there are images, data or files on the device that staff reasonably suspect are likely to put a person at risk, they will first consider the appropriate safeguarding response.

When deciding if there is a good reason to erase data or files from a device, staff members will consider if the material may constitute evidence relating to a suspected offence. In these instances, they will not delete the material, and the device will be handed to the police as soon as reasonably practicable. If the material is not suspected to be evidence in relation to an offence, staff members may delete it if:

- > They reasonably suspect that its continued existence is likely to cause harm to any person, and/or
- > The student and/or the parent/carer refuses to delete the material themselves

If a staff member **suspects** a device **may** contain an indecent image of a child (also known as a nude or semi-nude image), they will:

- > Not view the image
- Confiscate the device and report the incident to the DSL (or equivalent) immediately, who will decide what to do next. The DSL will make the decision in line with the DfE's latest guidance on <u>screening, searching and</u> <u>confiscation</u> and the UK Council for Internet Safety (UKCIS) guidance on <u>sharing nudes and semi-nudes: advice for</u> <u>education settings working with children and young people</u>

Any searching of students will be carried out in line with:

- > The DfE's latest guidance on searching, screening and confiscation
- UKCIS guidance on sharing nudes and semi-nudes: advice for education settings working with children and young people
- > Our behaviour policy, searching, screening and confiscation policy

Any complaints about searching for or deleting inappropriate images or files on students' electronic devices will be dealt with through the school complaints procedure.

6.4 Artificial intelligence (AI)

Generative artificial intelligence (AI) tools are now widespread and easy to access. Staff, students and parents/carers may be familiar with generative chatbots such as ChatGPT and Google Bard.

Blackfen School for Girls recognises that AI has many uses to help students learn, but may also have the potential to be used to bully others. For example, in the form of 'deepfakes', where AI is used to create images, audio or video hoaxes that look real. This includes deepfake pornography: pornographic content created using AI to include someone's likeness.

Blackfen School for Girls will treat any use of AI to bully students in line with our anti-bullying/behaviour policy.

Staff should be aware of the risks of using AI tools whilst they are still being developed and should carry out a risk assessment where new AI tools are being used by the Blackfen School for Girls.

7. Acceptable use of the internet in school

All students, parents/carers, staff, volunteers and governors are expected to sign an agreement regarding the acceptable use of the school's ICT systems and the internet (appendices 1 to 3). Visitors will be expected to read and agree to the school's terms on acceptable use if relevant.

Use of the school's internet must be for educational purposes only, or for the purpose of fulfilling the duties of an individual's role.

We will monitor the websites visited by students, staff, volunteers, governors and visitors (where relevant) to ensure they comply with the above and restrict access through filtering systems where appropriate.

More information is set out in the acceptable use agreements in appendices 1 to 3.

8. Students using mobile devices in school

Students may bring mobile devices into school, but are not permitted to use them during:

- > Lessons unless with permission
- > Form/Community time

Any use of mobile devices in school by students must be in line with the acceptable use agreement (see appendices I and 2).

Any breach of the acceptable use agreement by a student may trigger disciplinary action in line with the school behaviour policy, which may result in the confiscation of their device as set out in the school's behaviour policy.

9. Staff using work devices outside school

All staff members will take appropriate steps to ensure their devices remain secure. This includes, but is not limited to:

- Keeping the device password-protected strong passwords are at least 8 characters, with a combination of upper and lower-case letters, numbers and special characters (e.g., asterisk or currency symbol)
- Ensuring their hard drive is encrypted this means if the device is lost or stolen, no one can access the files stored on the hard drive by attaching it to a new device
- > Making sure the device locks if left inactive for a period of time
- > Not sharing the device among family or friends
- > Installing anti-virus and anti-spyware software
- > Keeping operating systems up to date by always installing the latest updates

Staff members must not use the device in any way that would violate the school's terms of acceptable use, as set out in appendix 3.

Work devices must be used solely for work activities.

If staff have any concerns over the security of their device, they must seek advice from CTS immediately by calling ext. 3115 and completing an <u>Askit@blackfen.bexley.sch.uk</u> form.

10. How the school will respond to issues of misuse

Where a student misuses the school's ICT systems or internet, we will follow the procedures set out in our policies on behaviour, mobile phones and the acceptable use policy. The action taken will depend on the individual circumstances, nature and seriousness of the specific incident, and will be proportionate.

Where a staff member misuses the school's ICT systems or the internet, or misuses a personal device where the action constitutes misconduct, the matter will be dealt with in accordance with the staff code of conduct and the AUP. The action taken will depend on the individual circumstances, nature and seriousness of the specific incident.

The school will consider whether incidents that involve illegal activity or content, or otherwise serious incidents, should be reported to the police.

II. Training

All new staff members will receive training, as part of their induction, on safe internet use and online safeguarding issues, including cyber-bullying and the risks of online radicalisation.

All staff members will receive refresher training at least once each academic year as part of safeguarding training, as well as relevant updates as required (for example through emails, e-bulletins and staff meetings).

By way of this training, all staff will be made aware that:

- Technology is a significant component in many safeguarding and wellbeing issues, and that children are at risk of online abuse
- > Children can abuse their peers online through:
 - o Abusive, threatening, harassing and misogynistic messages
 - Non-consensual sharing of indecent nude and semi-nude images and/or videos, especially around chat groups
 - Sharing of abusive images and pornography, to those who don't want to receive such content.

> Physical abuse, sexual violence and initiation/hazing type violence can all contain an online element

Training will also help staff:

• Develop better awareness to assist in spotting the signs and symptoms of online abuse

- Develop the ability to ensure students can recognise dangers and risks in online activity and can weigh up the risks
- Develop the ability to influence students to make the healthiest long-term choices and keep them safe from harm in the short term

The DSL will undertake child protection and safeguarding training, which will include online safety, at least every 2 years. They will also update their knowledge and skills on the subject of online safety at regular intervals, and at least annually.

Governors will receive training on safe internet use and online safeguarding issues as part of their safeguarding training.

Volunteers will receive appropriate training and updates, if applicable.

More information about safeguarding training is set out in our child protection and safeguarding policy.

12. Monitoring arrangements

The DSL logs behaviour and safeguarding issues related to online safety on safeguard my school

This policy will be reviewed every year by the AHT Curriculum and Assessment. At every review, the policy will be shared with the governing board. The review (such as the one available <u>here</u>) will be supported by an annual risk assessment that considers and reflects the risks students face online. This is important because technology, and the risks and harms related to it, evolve and change rapidly.

I3. Links with other policies

Appendix I: KS3 and KS4 acceptable use agreement (students and parents/carers)

ACCEPTABLE USE OF THE SCHOOL'S ICT SYSTEMS AND INTERNET: AGREEMENT FOR STUDENTS AND PARENTS/CARERS

Name of student:

I will read and follow the rules in the acceptable use agreement policy.

When I use the school's ICT systems (like computers) and get onto the internet in school I will:

- Always use the school's ICT systems and the internet responsibly and for educational purposes only
- Keep my usernames and passwords safe and not share these with others
- Keep my private information safe at all times and not give my name, address or telephone number to anyone without the permission of my teacher or parent/carer
- Report immediately if I find any material that might upset, distress or harm me or others
- Need to understand that the School has a robust filter for the internet and a system for monitoring computer usage, However, out of School and particularly on mobile phones connected to mobile networks, there is often no supervision, monitoring or filtering.
- Need to be aware that bullying another Blackfen student using the Internet, social networking sites, the School network, Office 365, School e-mail etc.... is still bullying and will be treated as such by the School. Students can expect to be sanctioned as set out in the School's Behaviour Policy, whether the incidents have been posted in School or out of School.
- Contact a social media platform if my account is hacked and ask they close any account created and/ or remove any offensive material.
- Always log off or shut down a computer when I've finished working on it

I will not:

- Access any inappropriate websites including: social networking sites, chat rooms and gaming sites unless my teacher has expressly allowed this as part of a learning activity
- Use any inappropriate language when communicating online, including in emails
- Arrange to meet anyone offline without first consulting my parent/carer, or without adult supervision
- Share or publish anything on social networking sites that identifies themselves as a Blackfen student.
- Share or publish anything on social networking sites that they would not want their parent/carer or other responsible adult to see.
- Share or publish anything on social media about a Blackfen student, their family or their friends, including their image without gaining their permission first.
- Share or publish anything on social media about anyone employed by Blacken School for Girls or provide a contracted service, including their image.
- Use any device to make a covert recording (voice or visual) of any other student or adult in school. The school does not allow this behaviour. If caught doing this at the time, or retrospectively, students must expect severe sanctions (including suspension) to be actioned by the school.
- Must not try to follow, send a friend request, contact or similar any member of staff at Blackfen via social media or using their own personal mobile phone, iPad, tablet, laptop etc.
- View or share inappropriate material, including that of another student or persons employed by the School, on a computer or on their own mobile device via social media or otherwise, I will receive a serious sanction as set out in the School's Behaviour Policy.
- link their school email address to any social networking site.

I agree that the school will monitor the websites I visit and that there will be consequences if I don't follow the rules.

ACCEPTABLE USE OF THE SCHOOL'S ICT SYSTEMS AND INTERNET: AGREEMENT FOR STUDENTS AND PARENTS/CARERS

Parent/carer's agreement:

- I understand that the school has a clear policy on the use of Internet based Social Media and that they and my child should actively support this.
- Must not take or obtain images of other students or staff and then share online, photographs, videos etc....without permission.
- The school does not allow students to make covert recordings (voice or visual) of any other student or adult in school. If caught doing this at the time, or retrospectively, parents/carers should expect severe sanctions (including suspension) to be actioned by the school.
- Should understand that the school will take any inappropriate behaviour seriously and will respond to observed or reported inappropriate or unsafe behaviour in accordance with the School's Behaviour Policy.
- Should understand that their child has agreed in the Acceptable User Policy to not to search for or share any
 material that could be considered offensive, harmful or illegal. This might include bullying or
 extremist/hate/discriminatory content.
- Must support the school by promoting safe and responsible use of the internet, online services and digital technology at home and will inform the school if they have any concerns.
- That my child is responsible for the content of their own social media account (s and must not share confidential login and password details of any accounts with another person. They will be held responsible for the content posted to their account. If a student's account is hacked, they are expected to contact the platform and close the account or remove any offensive material. The matter will be dealt with in line with the school's behavior policy.

NB - Students and Parent/Carers

- Parent/Carers should not use a student's Office365 email, Teams account or other School provided system to communicate with teachers or any other member of staff. These systems are for your child's use alone to participate in their learning. If a parent/carer wishes to discuss any aspect of their daughter's learning with a member of staff, they should contact by ringing the school or emailing using their own personal email.
- if the AUP is not followed, as outlined above, there will be an investigation carried out and this will result in at least a serious sanction, exclusion or the school reporting a student to the Police as set out in the School's Behaviour Policy.
- The School has a robust filter for the internet and a system for monitoring computer usage, However, out of School and particularly on mobile phones connected to the mobile networks, there is often no supervision, monitoring or filtering. It is therefore a student's responsibility to adhere to this guidance or face the consequences of their actions as set out in the School's Behaviour Policy.
